Please leave garbage can and recycle bins are accessible so that we will be able to leave any bulk work materials on-site. We will not be taking any work materials and/or trash from the "workspace".
- 11. Please turn off all heating, cooling and ventilation prior to our arrival.
- 12. We will not be sweeping or vacuuming, thus we will not be disturbing the airspace.
